I have probable cause to believe that on 04-09-2015, at 6203 Agnes in (Date) (Address)

Kansas City, Jackson Missouri Shyreif Carter (County) (Name of Offender(s))

BM 06-06-1996 SSN; 4 committed one or more criminal offense(s). (Description of Identity)

The facts supporting this belief are as follows:

On 04-09-2015 at approximately 1943hrs, Officers of the Kansas City Missouri Police Department were dispatched to area of 62nd and Agnes Ave, Kansas City, MO Jackson County, in regard to the sound of 7-9 shots and a grey vehicle parked down the street with the passenger door open. Officers found a deceased party inside a grey Oldsmobile Alero. The victim was identified as Shawndray Key B/M 04-20-1993. ME ruled the death as a Homicide.

On 04-09-2015, at approximately 1949hrs, a victim, later identified as Shyreif Carter B/M 06-06-1996 (SC), arrived at Research Medical Center with a gunshot wound to the left hand. SC stated he was with his brother (Teandre Carter B/M 01-18-1995 TC) and his brother's girlfriend "Erica" later identified as W/F 07-30-1996, in a white Kia when he was shot in the area of 79th and South Benton Blvd. He then stated they drove him to the hospital. SC stated his brother and "Erica" was heading to Lee's Summit, MO.

While officers were at Research Medical Center, security officers notified that SC and another individual, later identified as B/M 08-24-1995, both got out of a white 4dr vehicle similar to a Kia. lied about his identity and about arriving with the victim but eventually stated to detectives that TC, SC and an unknown B/F picked him up in the area of 35th and Park and stated they were going do a "lash", a robbery. asked who and they said "Drey". SC and TC had told that the Victim had a Glock that they wanted. told them to drop him off since he went to school with "Drey" and didn't want to be involved stated the B/F parked backwards in the driveway of TC and SC's grandmother's house located on the 6200 blk of Agnes. He said SC and TC both got out and walked down the block to an unknown vehicle. TC was on the driver's side and SC was on the passenger side heard gunshots and both Carter's ran back to the vehicle. TC asked SC if he got the gun and SC said "yes, but that he was shot in the hand." had seen TC with a gun but was unsure if SC had a gun or not. They drove to Research Medical Center and him and SC got out and TC and the BF left in an unknown direction.

A possible vehicle license was found for the white Kia and an address in Independence, MO. Detectives responded and conducted a residence check at 15071 E. 2nd St S in regard. While detectives were at the residence, the suspect vehicle, a white Kia with MO LIC PB2S9F pulled on to the street, completed a U-turn and drove away. Independence officers followed the vehicle and while doing so, a backpack was thrown from the passenger side door. The backpack was recovered and inside was a Glock 10mm, later determined to belong and to be registered to the Victim (Shawndray Key) a Glock .40 cal, ammunition magazines loaded with live rounds and loose ammunition. A car check was conducted on the White Kia at 2611 Lee's Summit Rd and Arika Cassidy and Teandre Carter were taken into custody.

█ stated she let her boyfriend, TC take her white Kia while she was at her house. At approximately 2000-2030, TC called and told her that his brother had been shot and that he was taking him to the hospital and then coming to get her. █ stated once TC arrived, they were to TC's dad's house off Hardesty Ave. She overheard TC tell his dad that they went to rob a guy and then SC got shot. He pulled out two guns and said "These aren't the ones used, I got rid of those". █ stated TC told her that he and his brother were at his grandmother's house off 62nd and Agnes when his brother was going to buy some drugs from a guy he knows. TC told █ that when SC went down to the car, something happened and his brother was shot in the hand. █ said TC's mom called and told him to stay at his dad's because the Police were looking for him. After a while, they were going to █'s house because TC thought the Police would not know about her. When they pulled on to her street, they both saw the police in front of her house and TC said "oh, shit" and told her to turn around. TC was on the phone with his dad who told him to come back to his house. █ stated she has seen TC with a gun and saw him with a gun yesterday. She stated TC robs people and sells marijuana.

TC stated he was driving █'s white Kia and he picked up SC and █. They went to an unknown location "out south." SC called an unknown male to meet them so SC could buy some weed from him. The male showed up in a grey or silver car and parked approximately 50 feet away. SC walked to the passenger side of the silver vehicle and █ walked to the driver's side window. SC opened the passenger door and TC heard gunshots. He looked up and observed SC and █ shooting into the car. TC stated █ had a black and silver 9mm and stated we would find 9mm shell casings by the driver's door. TC stated SC and █ ran back to the car and had been shot in the hand. TC stated he took SC to the hospital and TC went to his mother's. TC stated later in the evening █ was driving him to her house when they saw the police at █ residence. TC stated he threw a black bag out of the car that had a 10mm Glock handgun inside. He stated he knew the 10 mm belonged to the victim of the homicide.

SC stated he was going to buy weed from someone █ knew. TC was driving his girlfriend's white Kia and they parked in their grandmother's driveway. He and █ met the Victim down the street from his grandmother's house on 62nd and Agnes. SC stated he and █ were going to take the Victim's weed and gun. He got into the passenger side of a White Alero and as he was doing so, he observed the driver (Victim) had a black colored gun lying across his lap. Moments later, he and the Victim saw █ walk up towards the driver's door (SC used a hand gesture to describe █ holding a handgun as he walked up to the driver's door.) The Victim started to raise the gun that was in his lap, at which time, SC put his hand up towards the gun and he was struck by gunfire. He further explained that the original intent discussed prior to meeting the Victim was to take his Kush and his handgun. He admitted that he fired a semi-automatic 357 which matched shell casings found in and around the vehicle at the crime scene.
