I have probable cause to believe that on 2009-2015, at 1153 E 65 ST in (Date) (Address)

BM, 03-06-1969, 6'01", 275LBS, BLK/BRN, S# committed one or more criminal offense(s). (Description of Identity)

RAPE / SODOMY / CHILD MOLESTATION / CHILD ENDANGERING

The facts supporting this belief are as follows:

On 06-11-2015, officers with the Kansas City Missouri Police Department were contacted by KB, the mother of a 14-year-old female, in regard to a rape. KB stated disclosed the following: when she was approximately 8-years-old, while living with her grandparents, located at 1153 E 65th St., Kansas City, Jackson County, Missouri, she was raped by her uncle Jimmy. identified uncle Jimmy as, "JAMES L. CANADA, JR, BM, 03-06-1969. stated she woke up in the middle of the night, in order to use the restroom, when she observed her touching her younger asked CANADA what he was doing, and he replied, "playing a game." stated CANADA then began to touch her "inappropriately", and then put "it" in her. stated CANADA covered her mouth and told her he would kill her sister if she told anyone about the sexual abuse. stated her who she identified as BM, 08-25-1951, walked by the bedroom, observed the sexual abuse occurring, laughed, and then walked away.

On 06-11-2015, was contacted by an Investigator with Missouri Children's Division who did not disclose any knowledge of the sexual abuse. was not referred to the Child Protection Center.

On 06-24-2015, responded to the Child Protection Center in regard to a forensic interview. During the interview stated the following: when she was approximately 8-years-old, she was raped by her Uncle Jimmy, who she identified as JAMES L. CANADA, JR, BM, 03-06-1969. stated this occurred while she was living with her grandparents, located at 1153 E. 65th St., KCMO. She stated she got up in the middle of the night, in order to use the restroom, when she observed CANADA touching her younger sister, on the chest. stated CANADA later put her on a bed, removed her clothing and began touching her on her chest and "down there." stated CANADA put his "private" inside her "private", covered her mouth, and told her he would kill her sister if she screamed. stated CANADA flipped her over on the bed, so her "bottom" was in the air, and was "messaging" with her "backside." identified her "private" as her vagina, and CANADA's penis as "monster", on an anatomically correct drawing. stated her who was identified as BM, 08-25-1951, opened the bedroom door, observed CANADA sexually abusing her, laughed at her, closed the door and left.

On 08-25-2015, a detective contacted a 19-year-old female, who stated she was the cousin to and she acknowledged had recently disclosed having been sexually abused by her uncle, JAMES L. CANADA. also disclosed the following: when she was approximately 12-or-13-years old, while she was spending the night at her grandparent's residence, located at 1153 E. 65th, KCMO, she was sleeping on the living room couch,

when JAMES L. CANADA came into the living room and touched her breasts [redacted] stated CANADA reached under her shirt and bra, and rubbed her breasts, skin-to-skin. [redacted] stated she disclosed the sexual abuse to her [redacted] whom she identified as [redacted] however, her [redacted] tried to convince her the incident did not occur.

On 10-20-2015, officers with the Kansas City Missouri Police Department were contacted by [redacted] an investigator with the Missouri Children's Division, [redacted], in regard to the sodomy of [redacted] an 8-year-old female. According to [redacted] [redacted] disclosed the following: her [redacted] whom she identified as JAMES L. CANADA, BM, 03-06-1969, had put lotion on his penis and stuck it in her "butt", on an unknown date in September of 2015. [redacted] disclosed this occurred at her uncle's residence, which was identified as 1153 E. 65th St., Kansas City, Jackson County, Missouri.

On 11-09-2015, [redacted] responded to the Child Protection Center in regard to a forensic interview. During the interview [redacted] disclosed the following: [redacted] identified the breasts as the "nipples", the vagina as a "private", and the buttocks as a "behind", on an anatomically correct drawing. [redacted] stated she doesn't like the "touches" she received from her "Uncle Jimmy." [redacted] stated "Jimmy" touched her "private and behind", while she was in CANADA's bedroom. AC stated "Jimmy" was "digged" his hand in her underwear, and touched the "inside" of her vagina. [redacted] stated this felt "not comfortable", and she did not tell anyone, because she was afraid she would get into trouble. [redacted] stated during another incident, she was asleep on the floor when she woke up with "Jimmy's" hand on the skin of her "behind." [redacted] stated "Jimmy" put lotion on his "private part", and put his "private part" in her "private" and her "behind." [redacted] stated she was lying on her side, and she felt something come out of "Jimmy's private", because she "felt drips." On another occasion, [redacted] stated "Jimmy" made her put his "private" in her mouth and there was "pee on it." [redacted] stated she later disclosed the sexual abuse to her [redacted] however, [redacted] stated her grandmother did not call the police.

On 11-09-2015, a detective with the Kansas City Crimes Against Children's Unit contacted [redacted] the [redacted] of [redacted] who identified "Jimmy", as the victim's [redacted]

On 11-18-2015, a detective with the Kansas City Crimes Against Children's Unit contacted [redacted] and verified "Jimmy", was JAMES L. CANADA, BM, 03-06-1969.
