Count I. Statutory Rape 1st Degree - Sexual Intercourse With A Person Less Than 14 Years Old (566.032-001Y199511980)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.032, RSMo, committed the felony of statutory rape in the first degree, punishable upon conviction under Section 566.032, RSMo, and subject to lifetime supervision under Sections 217.735 and 559.106, RSMo, in that on or between April 29, 2015 and April 29, 2017, in the County of Jackson, State of Missouri, the defendant knowingly had sexual intercourse with

The range of punishment for the unclassified felony of statutory rape in the first degree – sexual intercourse with a person less than 14 years old is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than five years.

Count II. Statutory Rape - 2nd Degree (566.034-001Y201711980)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.034, RSMo, committed the class D felony of statutory rape in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or about on or between April 29, 2017, and August 2, 2017, in the County of Jackson, State of Missouri, the defendant had sexual intercourse with and at that time was less than seventeen years old and the defendant was twenty-one years of age or older.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count III. Sexual Misconduct Involving A Child Under 15 - 1st Offense (566.083-002Y201736990)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.083, RSMo, committed the **Class E Felony of Sexual Misconduct Involving a Child**, punishable upon conviction under Sections 566.083, 558.011, and 558.002, RSMo, in that on or about August 2, 2017, the defendant knowingly exposed defendant's genitals to ., a child less than fifteen years of age, and did so for the purpose of arousing the sexual desire of defendant.

The range of punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count IV. Child Molestation - 4th Degree - Child Less Than 17 Yoa And Offender Greater Than 4 Years Older (566.071-001Y201736180)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.071, RSMo, committed the Class E Felony of Child Molestation in the fourth degree,

punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or between about April 29, 2017, and August 2, 2017, in the County of Jackson, State of Missouri, the defendant, who was more than four years older than , for the purpose of arousing or gratifying the sexual desire of defendant, subjected , who was then less than seventeen years of age, to sexual contact by touching s breasts through the clothing.

The range of punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count V. Child Molestation - 4th Degree - Child Less Than 17 Yoa And Offender Greater Than 4 Years Older (566.071-001Y201736180)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.071, RSMo, committed the Class E Felony of Child Molestation in the fourth degree, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or between April 29, 2017, and August 2, 2017, in the County of Jackson, State of Missouri, the defendant, who was more than four years older than four years of arousing or gratifying the sexual desire of defendant, subjected who was then less than seventeen years of age, to sexual contact by touching s breasts.

The range of punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count VI. Enticement Or Attempted Enticement Of A Child (actor 21 Yrs Of Age Or Older And Child Less Than 15 Yrs Of Age) (566.151-001Y201764100)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.151, RSMo, committed the **Felony of Enticement of a Child**, punishable upon conviction under Section 566.151, RSMo, and is subject to lifetime supervision under Section 217.735, RSMo, in that on or between February 1, 2017, and April 28, 2017, in the

County of Jackson, State of Missouri, the defendant, who was twenty-one years of age or older, enticed who was less than fifteen years of age, by removing his clothing in her presence, and the defendant did so for the purpose of engaging in sexual conduct with a person less than fifteen years of age.

An individual convicted of this offense is not eligible for probation or parole for a period of five years.

Defendant is a prior offender under Section 558.016, RSMo., in that he has pleaded guilty to a felony as follows:

1. On or about October 16, 1998, defendant pleaded guilty to the felony of burglary in the first degree in the Circuit Court of Jackson County, Missouri, in case number 16CR96002001.


