Count I. Harassment - 1st Degree (565.090-003Y20205399.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.090, RSMo, committed the class E felony of harassment in the first degree, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or about April 15, 2025, in the County of Jackson, State of Missouri, the defendant, acting alone or purposefully in concert with others, without good cause, engaged in an act with the purpose to cause emotional distress to by blocking the vehicle she was in with tow trucks, preventing her from leaving and such act did cause suffer emotional distress.

The range punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count II. Harassment - 1st Degree (565.090-003Y20205399.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.090, RSMo, committed the class E felony of harassment in the first degree, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or about April 15, 2025, in the County of Jackson, State of Missouri, the defendant, acting alone of purposefully in concert with others, without good cause, engaged in an act with the purpose to cause emotional distress to by blocking the vehicle he was in with tow trucks, preventing him from leaving and such act did cause suffer emotional distress.
