Aggravated Assault

The facts supporting this belief are as follows:

On 05/09/2025, while on active patrol conducting traffic enforcement, officers of the Kansas City Missouri Police Department attempted to conduct a traffic stop of ATV's at Southwest Blvd and 31st St, Kansas City, Jackson County, Missouri. During the stop the initial ATV's fled from the officers who were in a marked KCPD patrol vehicle. However, while the initial vehicles fled a silver Infiniti sedan began doing burnouts and donuts in the intersection in front of the officers. While the driver was performing those stunts PO [REDACTED] (Victim) and PO [REDACTED] (Victim) observed the rear passenger side window to be halfway rolled down. [REDACTED] and [REDACTED] both observed the occupant of the rear passenger seat of the Infiniti extended his hand out of the open window and point a black handgun with a green laser attachment directly at them inside their marked patrol vehicle.

McMahon and Anderson then activated their lights and sirens in an attempt to stop the vehicle which immediately fled. They pursued the vehicle eastbound on Southwest Boulevard.

The vehicle entered I-35 southbound and entered into Kansas, driving at speeds over 90 miles per hour. The vehicle turned northbound on 18th Street Expressway and exited Steele Road and turned eastbound. The vehicle made several turns as officers still continued to chase the vehicle and it entered I-35 northbound and came back into Missouri, again driving at speeds over 90 miles per hour. The vehicle exited I-35 and turned westbound on 20th Street. The vehicle turned westbound on 31st Street from Southwest Trafficway and turned East on Southwest Boulevard. Officers with the Tactical Response Team conducted a TVI at 26th Street and Southwest Boulevard. The vehicle recovered from the TVI and continued eastbound. Underneath I-35, the vehicle was involved in an accident with another vehicle. Afterwards, four parties exited the vehicle and fled on foot.

Officers pursued the driver, later identified as Carlos NAJERA, H/M [REDACTED], on foot for approximately one block before taking NAJERA into custody. NAJERA refused to provide his name and information to officers after being detained. Officers located a wallet with a driver's license, which had the name of Carlos NAJERA, and NAJERA then confirmed his identity.

The silver Infinity G37 was inventoried prior to being towed and officers located a loaded black Glock 19x 9mm with a green laser attachment and a loaded brown Glock 19x 9mm on the passenger's front floorboard. A third gun was located between the driver's seat and the center console.

A warrant is requested and a bond is requested to be associated with that warrant due to the following factors: Najera actively fled from officers in a vehicle in a dangerous and reckless manner attempting to prevent the prosecution of another individual in the vehicle for aggravated assault.
