The facts supporting this belief are as follows:

On 06/21/2025 at 1018 hours, officers with the Kansas City Missouri Police Department were dispatched to [REDACTED]
[REDACTED] Jackson County, Missouri, on a reported shooting.Upon arrival, officers located [REDACTED] outside in a panic. She advised her boyfriend, [REDACTED] was shot by [REDACTED] De'Onte Thompson. [REDACTED] was located in the kitchen suffering from gunshot wounds to his back. EMS transported [REDACTED] to Truman Medical Center. [REDACTED] was later pronounced deceased by medical staff at 1436 hours.

Two spent 9mm shell casings were located in the grass near the back-patio door. Just inside the back door is the kitchen where a large amount of blood was located.

[REDACTED] had defects from apparent bullets to his right wrist, right forearm, right lower back and right upper buttocks.[REDACTED] told detectives she and [REDACTED] were in bed when they heard a knock at the back door. She told [REDACTED] to go answer the door because she had no clothes on. She heard a commotion and her brother's voice. She walked towards the hallway and heard [REDACTED] De'Onte, yell, "Bitch ass nigga, don't move." She heard three gunshots and observed [REDACTED] trying to close the back door on De'Onte. She stated [REDACTED] had already turned around and was facing away from De'Onte while De'Onte was half in and out of the door. De'Onte turned and ran east behind her apartment. [REDACTED] advised De'Onte only has one eye and the eyelid where his eye is missing is droopy.

A photo of De'Onte Thompson was obtained which showed him to be missing his left eye and the eyelid around it to be droopy.

After the shooting, [REDACTED] called [REDACTED], who told her De'Onte was at her residence in his bedroom.

On 06/23/2025, [REDACTED] was contacted to get a phone number for De'Onte. She advised his phone number is [REDACTED] and he called her phone right before the homicide occurred. She also heard from [REDACTED] De'Onte and [REDACTED], fled to St. Louis. [REDACTED] told her not to speak with police or tell police De'Onte was involved.

On 06/26/2025 a court order for the [REDACTED] was applied for and granted through the Circuit Court of Jackson County, Missouri. The call detail records were obtained and subsequently used to map the cell phone's location. It was determined the cell phone was in the area of the crime scene at the time of the homicide.

On 06/27/2025 De'Onte was arrested on an investigative hold and transported to Kansas City, Missouri Police Headquarters. De'Onte requested a lawyer and declined to provide a statement.
