I, Detective Mark Curd #42/0322, of the Jackson County, Missouri Sheriff's Office, knowing that false statements on this form are punishable by law, state that the facts contained herein are true:

- 1. I have probable cause to believe that on 9/27/25 at approximately 1600 hours, at or near Kansas City, MO 64126, Jackson County, Missouri, SUSPECT 1, ROSCOE, NATHAN Day County , last known address: KANSAS CITY, MO 64152, committed one or more criminal offense(s).

2. The facts supporting this belief are as follows:
On 9/27/2025, at approximately 1600 hours, Jackson County Sheriff's Office Deputies responded to Kansas City, MO), Jackson County 64126, in reference to shots fired inside the residence. While en route, (W1) stated Victim 1, dispatch personnel advised Witness 1, (V1) was snot in the head by Suspect 1 (S1) vi was still preathing.

After responding to the area Deputy Brice #50, Deputy Ly #87, Deputy Norton #66, and Deputy Curd #91 maintained perimeter around the residence, While Deputy Davidson #79 made phone contact with W1, at the Inner City Fire Department and was able to obtain a phone number for S1. Deputy Davidson contacted S1 by phone and was able to get all parties to exit the residence.

Deputy Brice reported while conversing with V1, who was alert and conscious, he ,(Deputy Brice) observed an obvious wound on the right side of V1's head as well as blood and an unknown clear/hazy liquid, which was later believed to be Vaseline that V1 had applied himself to the wound. V1 advised S1 believed he was "snitching" and was yelling at him about it. V1 stated while he was walking downstairs S1 was behind him and S1 shot him. V1 did not know what he was shot with but believed it to be a gun. V1 stated he utilized a towel to contain the blood on his head. V1 was transported to North Kansas City Hospital by EMS, where he was treated for a gun shot wound to the head. urt Document - Not an Official Court Document - Not an Official Court Document - Not an Offi-

W1 and W2 were reported to be inside the home at the time of the incident. Both W1 and W2 advised that they were not in the basement with V1 and S1, but did report hearing a gunshot.

S1 was taken into custody and transported to the Jackson County Jail pending further investigation.

While conducting a protective sweep of the residence, Deputies observed drops of blood at the bottom of the stairs inside the residence. They also observed a white t-shirt in a bathtub inside the residence, with apparent blood on it.

STATEMENT OF PROBABLE CAUSE

DATE: 9/28/2025

During phone interview with V1, Detective M. Curd #42 was told by V1 that S1 instructed V1 to go down stairs and look for some missing keys. V1 advised as he was on the second or third step down, with S1 right behind him, he heard a gunshot and was struck in the right side of the head. that he put his hand to his head and saw that he was bleeding. V1 advised S1 then guided him to the bathroom and began to treat the wound by applying pressure, washing the blood away with water and then assisting with packing the wound with Vaseline, in an attempt to get the bleeding to stop and cover up the injury. V1 advised that as S1 was doing all this he continuously grabbed at something in his pants pocket. V1 further advised that after S1 tried to cover up the injury and was on the phone with Deputy Davidson, S1 went into W1's room for a moment before complying with the Deputies orders to exit the residence. V1 advised he never saw S1 with with a weapon but was sure S1 shot him with one. V1 advised that he did believe S1 shot him in the head and that he (V1) was willing to aid in prosecution in this incident cument Not an Official Court Document Not an Official Court Document Not an Official

A search warrant for the residence was applied for by Sgt. Berger #29, and granted, to locate an unknown make and model firearm and/or firearm components that were used in the crime, spent shell casings, bullets, ammunition, and the observed shirt with apparent blood.

Detective Curd located a loaded black Glock 27, 40 caliber pistol between the mattress and box springs, located in W1's bedroom. Next to the pistol was a loaded extended Glock magazine capable of holding 22 40 caliber rounds of ammo. After photographing and upon making the weapon safe, Detective Curd observed there to be 1 live Federal Smith and Wesson round, (with a brass in color casing,) in the chamber. He further observed there to be 3 Tulammo 40 caliber Smith and Wesson (with a gray in color casing) and 4 Federal 40 Caliber Smith and Wesson live rounds loaded into the magazine that was ejected from the pistol. In the 22 round extended magazine, Detective Curd found there to be 11 Tulammo rounds and 10 Federal rounds. It should be noted that the rounds were stacked into both magazines as follows. 1 Tulammo round, followed by a Federal round, then a Tulammo round, followed by another Federal round and so on.

In the bathroom of the residence, Detective Curd recovered a wet white t-shirt with apparent blood stains, from the bathtub.

In the stairwell of the basement, a spent Tulammo, gray in color casing was found, above the stairs, on a shelf, near the wall.

Detective Curd took photos of dried drops of blood on the bottom step and floor of the basement.

All items were photographed and recovered as evidence.

STATEMENT OF PROBABLE CAUSE

DATE:9/28/2025

At 2155 hours, Detective Curd responded to the Jackson County Jail to interview S1. Upon arrival Detective Curd was informed by Detention staff that while searching S1, they recovered 1 live Tulammo Smith and Wesson 40 Caliber round of ammo from S1's front pants pocket. This item was also recovered as evidence.

Upon speaking with S1 after informing him of his Rights per Miranda, S1 advised Detective Curd that he was a felon and could not possess a firearm. Detective Curd asked S1 if he could possess a magazine to a firearm. S1 advised no. S1 was asked if he could possess ammunition for a firearm. S1 advised no. Detective Curd then asked S1 if he wasn't allowed to possess ammunition, then why was a 40 caliber round, matching that of the rounds located at the scene, in a Glock 40 Caliber pistol, that was believed to be used in a shooting, where V1 was shot in the head, located in his (S1's) pants pocket when he arrived to the Jackson County Jail. At that time, Detective Curd was informed by S1 that he wished to have an attorney and the interview was ended.

V1 was treated for a gun shot wound to the right side of his head. It was reported the bullet did not penetrate his skull, but did cause injury to the right side of his scalp. Upon last update he was being held over night for observation.
