**Count I. Assault 2nd Degree (565.060-001Y19841399.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.060, RSMo, committed the **Class C Felony of Assault in the Second Degree**, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or about August 27, 2016, in the County of Jackson, State of Missouri, the defendant recklessly caused serious physical injury to [REDACTED] by shooting him.

**Count II. Armed Criminal Action (571.015-001Y19755213.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section (571.015.1) (571.015.2) (571.015.3), RSMo, in that on or about August 27, 2016, in the county of Jackson, State of Missouri, the defendant committed the felony of Assault in the Second Degree charged in Count 1, all allegations of which are incorporated herein by reference, and the defendant

committed the foregoing felony of Assault in the Second Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

**Count III. Unlawful Possession Of A Firearm (571.070-001Y20085212.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of 571.070, RSMo, committed the **Class C Felony of Unlawful Possession of a Firearm**, punishable under Sections 558.011 and 560.011, RSMo, in that on or about August 27, 2016, in the County of Jackson, State of Missouri, the defendant knowingly possessed a 9 millimeter handgun, a firearm, and on September 2, 2011, the defendant was convicted of the felony of unlawful use of a weapon in the Circuit Court of Jackson County, Missouri.



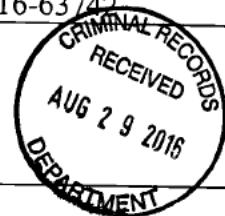

I have probable cause to believe that on 08-27-2016 (Date), at 5514 Wabash Av (Address) in

The facts supporting this belief are as follows:

On 08-27-2016 Officers of the Kansas City, Missouri Police Department were dispatched to **5514 Wabash Av, Kansas City, Jackson County, Missouri** on a shooting.

Officers responded and contacted the victim who was inside the residence with an apparent gunshot wound to the head. The victim was transported to an area hospital and was not able to provide a statement due to emergency treatment of the injury.

Officers contacted the witness who said her brother and the victim were inside when she heard a pop and Derrick Dennis came outside and stated "we have to go, the gun just went off." The witness said she went inside and found the victim who had been shot. The witness said Derrick Dennis left the area on foot.

The witness provided a formal statement to detectives. The witness said she and the victim reside together at 5514 Wabash Av. and the suspect Derrick Dennis is her brother who came over. The witness said she did not see the shooting but the victim and Derrick Dennis were inside when she heard a gunshot and went inside to find the victim had been shot. The witness said Derrick Dennis said the gun just went off and he did not mean to shoot the victim and was stuffing the gun into his pants as he left the scene. The witness said there were no guns at the residence prior to Derrick Dennis arriving.


Officers located and apprehended Derrick Dennis at 5409 Wayne Av and transported him to headquarters for questioning. Derrick Dennis waived his Miranda rights and gave a statement to detectives. Detectives observed a large scratch on Derrick Dennis' chest that he claimed he received in the fight. Derrick Dennis told detectives that he had the gun for a while and he and the victim started fighting, and then claimed they were not really fighting. Derrick Dennis claimed the victim had a rifle and described it as an AK47 or SKS style firearm. Derrick Dennis said they were messing around with the guns including quick drawing and his gun just went off. Derrick Dennis described his gun as a 9 millimeter. Detectives asked Derrick Dennis what he did with the gun



and he said he threw it in the river. When trying to determine a better location, Derrick Dennis said it was Brush Creek at the Paseo Bridge. Detectives obtained a search warrant for the residence at 5409 Wayne Av. however they did not locate any firearm.

Derrick Dennis is a convicted felon and prohibited from possession of firearms and ammunition. The conviction was on 09-02-2011 through the Circuit Court of Jackson County Missouri for unlawful use of a weapon with a court case number 1116-CR0161701.
